1 Project Objective

Build/set up and initially maintain the core mechanisms of the Caribbean Telecentres (ACT!) as a regional framework for sharing and collaboration among Caribbean telecentres.

2 Background

The project concept is based on the outputs of the Caribbean Telecenters workshop, held in Dominican Republic in July 2006 (<u>http://taiguey.org/CTW/</u>), with more than 60 telecenter related stakeholders.

Post workshop task force defined the *Alliance of Caribbean Telecentres (ACT!)* and this project aims to put in place the mechanism and organization-ware for its sustainability.

The Alliance of Caribbean Telecentres (ACT!) has the objective to enable and promote sharing and collaboration among Caribbean telecentres, to strengthen the impact of telecentres initiatives in the communities.

This includes objectives

- Facilitating knowledge sharing and information exchange
- Facilitating the development of collaborative projects
- Facilitating technical peer to peer support and/or access to external technical support to telecenters of the region
- promoting the digital democracy/inclusion and the right to information and to inform
- promoting community empowerment and transformation capacity into the rural and urban marginal communities

3 Expected results:

After 2 years:

- i. ACT! is vibrant, autonomous, self-managed, sustainable community of Caribbean telecentre stakeholders.
- ii. Members interacts via virtual space and face to face events, network, share information (general and thematic), learn, access resources, services and tools, collaborate in regional projects, etc..
- iii. It uses a multilingual online platform that supports a helpdesk, services channeling, and multiple sections/discussion channels, and databases.
- iv. A team of alliance members animates thematic discussions, web sections, develops services and tools, and coordinate regional collaborative projects
- v. Telecenter managers and promoters have developed capacities (via peer learning, training workshops, access to services and resources, etc.) that allows them to strengthen their telecentre operations;
- vi. Collaborative regional projects by members and in benefit of the alliance, have been developed;
- vii. 4 Capacity building events have been implemented.

4 Activities

The activities are geared towards

- → Developing animation and facilitation activities to strengthen networking and information sharing (general and thematic) among members
- → Building an online platform that will support multiple sections/discussion, access to resources, helpdesk, access to services and tools, with sections/channels managed by the members
- → Building capacity for telecenter managers and promoters in aspects related to strengthening their telecentre operations;
- → Building capacity in a team of alliance members to animate thematic discussions, web sections, develop services and tools, coordinate regional collaborative projects
- → Promoting the developing of collaborative regional projects by members and in benefit of the alliance, results/outputs to be presented at the annual capacity building event.

4.1 Platform and tools

ACT 1. Set up the complex web site with several forums/thematic sections/ mailing list(s), database etc. (the ACT! Web site and its thematic exchanges mechanics and all related tools)

- ACT 2. Develop scripts for multilingual automatic translation of messages and content
- ACT 3. Maintain, and upgrade system as needed (Technical coordination Platform)

4.2 Animation and networking (+ facilitators capacity development)

- ACT 4. Define ACT! chart have it approved by initial members (CTW workshop participants), Governance aspects -and open and promote the membership
- ACT 5. Facilitate the selection process by membership of the national/task/thematic channel facilitators with their own mandate
- ACT 6. Face to Face Training workshop for facilitators how to use the web, facilitate thematic discussion on line, maintain their thematic section, promote/develop projects, 20 participants. (Governance aspects also be part of this)
- ACT 7. Organize mechanism and facilitate tools for the functioning of the Facilitators committee
- ACT 8. Moderate main mailing list
- ACT 9. Coordination/management of website contents "suppliers"
- ACT 10. Moderation of virtual thematic working groups

4.3 Research and data

- ACT 11. Survey and research on Caribbean Telecentres (updating and expanding previous on prepared for CTW), permanently monitoring and updating map/listing.
- ACT 12. Design of the database structure, editorial policy, and content acquisition, approval of resources, management

4.4 Regional Collaborative projects

- ACT 13. Support for project development (technical support for members to put up projects together, develop proposal)
- ACT 14. Phase 1 Small Collaborative Project implementation: projects which outputs are material for the annual event. Projects definition will be promoted by the thematic facilitators/groups.
 - → Content /manuals, studies to be used for training workshop at annual event.
 - → Feasibility/concept studies for bigger projects to be also presented/discussed/launched at annual event. (project progress will be blogged on the site)
 - → develop support services (helpdesk), content and shared services for the telecentres in the region
- ACT 15. Phase 2: bigger collaborative project, build on phase 1 outputs and lessons, to be implemented in a year time frame, and presented 2nd event. (project progress will be blogged on the site)

4.5 Annual ACT! meeting/workshop

- ACT 16. 4-5 days event that include:
 - → training workshop for ACT membership (as: multimedia and radio, sustainability strategies, wireless connectivity, open source software, community empowerment methodologies, platforms, services, etc)
 - → Present use and diffuse results of collaborative projects of the ACT! projects results: manuals, methods, tools, helpdesk, acces to services, etc
 - → Several parallel tracks (discussions) in all areas for developing projects and services for members,
 - \rightarrow General ACT! assembly

7 Implementation arrangement

The Act!ivate project implementation will be carried out by the CarISnet consortium who is developing activities since 2004 to strengthen ICT4D actors in the Caribbean (Civic strengthening, ICT4D Caribbean online clearinghouse wwww.carisnet.org). This will create positive synergies and integration between integrating Act!ivate and Carisnet-2 project that is definition phase.. The group will also benefit from useful lessons learned on implementing a collaborative regional project, from the Carisnet-1.

Current CarISnet consortium members are JSNDP (Jamaica), Fundación Taiguey (Dominican Republic) and DevNet (Guyana), but membership is expected to change/grow soon when Carisnet2 is launched. Letter of intention are being drafted with ICT4D Jamaica that has an important telecentre related project in Jamaica, and AHTIC of Haiti.

In a meeting held in Santo Domingo (nov 30-Dec 2 2006) the CarlSnet Consortium agreed to:

- Engage into the Act!ivate project implementation
- have Fundación Taiguey (Dominican Republic) as project leader, and operates in similar mode that CarISnet-1 was implemented, adding to it the lessons from the process of implementing a collaborative, region wide, project.
